## **Concluding Remarks**

### **Charita Castro**

Director for Labor Affairs, Office of the U.S. Trade Representative

Charita Castro, Ph.D., is director for labor affairs at the Office of the U.S. Trade Representative (USTR), where she works at the intersection of workers' rights and trade. Castro uses her extensive research and analysis experience to cover bilateral and multilateral forced labor and human trafficking issues in East Asia, including China, and Southeast Asia.

Previously, she served as the chief of research and policy at the U.S. Department of Labor's Office of Child Labor, Forced Labor, and Human Trafficking. There she directed a team that published congressionally mandated reports on child labor and forced labor and launched the first U.S. government mobile applications on human rights, *Sweat & Toil*.

Castro represented the U S. government at the International Labour Organization negotiation of the 2018 *Guidelines Concerning the Measurement of Forced Labour*. In addition, she earned a Fulbright fellowship to research the impact of hazardous work on child agricultural laborers in the Philippines.



Castro was a Presidential Management Fellow in 1999 and also worked at the U.S. Census Bureau and the U.S. Department of Health and Human Services.

She was selected as one of 125 American Association for the Advancement of Science IF/THEN Ambassadors® to promote the next generation of female scientists.

Castro received her Doctor of Philosophy in public policy from The George Washington University, a Master of Social Work from The Brown School at the Washington University in St. Louis, and her Bachelor of Science in psychology from Tulane University.

# **Declan Croucher** Senior Director for Advisory Services, Verité



Declan Croucher is senior director of advisory services at Verité, a U.S.-based international not-for-profit consulting, training, and research organization that is a leader in supply chain social responsibility.

Croucher is responsible for Verité's corporate outreach and engagement where he helps companies detect, remedy, and prevent forced labor, human trafficking, and modern slavery in their global supply chains. In addition, he leads Verité engagements with worldwide companies in diverse sectors, including consumer electronics, apparel, pharmaceuticals, medical devices, food and beverages, construction, extractives, and government contracting.

Previously, Croucher held roles in human resources and business management with multinational manufacturers in the consumer electronics, building products, and renewable energy sectors.

He has undergraduate degrees in business and law and a master's degree in strategic human resources management.

### **Neil Giles**

Chief Executive, Traffik Analysis Hub

Neil Giles, chief executive of the Traffik Analysis Hub, has 36 years of law enforcement experience in the U.K. As a specialist in intelligence collection, he possesses extensive knowledge of organized crime and human trafficking.

Following public service, Giles joined <u>STOP THE TRAFFIK</u> as director of intelligence. <u>STOP THE TRAFFIK</u> is a non-governmental organization in the U.K. that collates data on human trafficking cases and profiles traffickers by analyzing trends.

<u>Traffik Analysis Hub</u> is a cross-sector initiative developed by STOP THE TRAFFIK in partnership with IBM and Clifford Chance. The platform uses AI system IBM Watson and the



IBM Cloud, while working with law enforcement authorities and financial services institutions in a bid to disrupt human trafficking routes and the associated money laundering schemes.
